WAIVER AND RELEASE OF LIABILITY

I AM AWARE OF THE RISKS ASSOCIATED WITH PARTICIPATION IN THESE ACTIVITES, WHICH MAY INCLUDE, BUT NOT LIMITED TO: PHYSICAL OR PSYCOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC LOSS OR EMOTIONAL LOSS, AND DEATH. I FURTHER acknowledge that Releasees are not responsible for errors, omissions, acts or failures to act of any party or entities conducting a specific event or activity on behalf of Releasees. In the event that I or any participant in the Activities I am hosting should require medical care or treatment, I authorize Trailhead Bike and Bed, LLC to provide all emergency medical care deemed necessary, including but not limited to, first aid, CPR, the use of AED's, emergency medical transport, and sharing of medical information with medical personnel. I further agree to assume all cost involved and agree to be financially responsible for any costs

incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance or coverage to protect myself and Releasees when hosting Activities.

I FURTHER acknowledge that these activities may involve a test of a person's physical or mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to participate or as host allow others to participate in Activities unless I am or they are medically able and properly trained, and I agree to abide by the decisions of Trailhead Bike and Bed, LLC officials or agent, regarding my approval to participate in the Activities.

I HEREBY ACKNOWLEDGE THAT I HAVE CAREFULLY READ AND CONSIDERED THIS "WAIVER AND RELEASE: AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE TRAILHEAD BIKE AND BED, LLC AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCESSORS AND ASSIGNS, FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING LEGAL ACTION AGAINST TRAILHEAD BIKE AND BED, LLC FOR PERSONAL PHYICAL OR EMOTIONAL INJURY OR FOR PROPERTY DAMAGE.

To the extent that the statute or case law does not prohibit release for ordinary negligence, this release is also for such negligence on the part of Trailhead Bike and Bed, LLC, its agents, and employees.

I agree that this Release shall be governed for all purposes by Mississippi law, without regard to any conflict of law principles. This Release supersedes any and all previous oral or written promises or other agreements.

In the event that any damage to equipment or facilities occurs as a result of my or my family's, my agent's, or as host any person's I allow to participate in the Activities willful actions, negligence or recklessness, I acknowledge and agree to be held liable for any and all cost associated with such action of willful, negligence, or recklessness.

THIS WAIVER AND RELEASE SHALL REMAIN IN EFFECT FOR THE DURATION OF MY PARTICIPATION IN AND/OR HOSTING OF THE ACTIVITIES, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.

THIS AGREEMENT was entered into at arm's-length, without duress or coercion, and is to be interpreted as an agreement between tow parties of equal bargaining strength. Both Participant, _____ and Trailhead Bike and Bed, LLC agree that this agreement is clear and unambiguous as to its terms, and that no other evidence shall be used or admitted to alter or explain the terms of this agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.

In the event that any provisions contained within this Release of Liability shall be deemed to be severable or invalid, or if any term condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall

remain in full force and effect. If a court should find that any provision of this agreement to be invalid or unenforceable, by that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed, and enforced as so limited.
